



THE GIS SCHOLARSHIP PROGRAMME 2019

Terms & Conditions

This document outlines the Terms and Conditions for scholarships by Garden International School, Kuala Lumpur; herein referred to as "GIS". You must read these Terms and Conditions in full. Upon acceptance of a scholarship from the School, it is understood that you have read and agree to comply with these Terms and Conditions.

Please note that that these Terms & Conditions are in addition to the Terms & Conditions governing enrolment and admission as stated on the 'Application for Admission' form.

Applications

Applications must be submitted within the following period : **Monday, 7th January 2019 to Monday, 11th March 2019**. No late applications will be entertained.

An 'application' refers to submission of a fully completed 'Application for Admission' Form to Garden International School, Kuala Lumpur with all required documents as stated on the checklist on the form.

The acceptance of an application is at the absolute discretion of the School. The School reserves the right to decline an application and is not obliged to offer any justification for the rejection of any application.

Application Success

Successful scholarship applicants will receive a Letter of Offer no later than **Monday, 1st April 2019**, detailing the scholarship benefits and payment timing. If you do not wish to accept a scholarship that your child has been offered, you should advise us immediately in writing.

Scholars will enjoy a waiver of the Application and Registration Fees. The applicable Tuition Fee, Technology Fee, Deposit and any other applicable fees will be stated on the Letter of Offer.

How will the Offer of Place and Scholarship be valid

The full sum of the applicable fees as stated on the Letter of Offer must be received by the School **on or before the Last Date to Accept the Offer as stated on the Letter of Offer**. Payment must be made in Ringgit Malaysia with a local cheque or banker's draft or an Online Transfer to "Garden International School Sdn Bhd".



The offer of place and scholarship will no longer be valid if:

- a. the full sum of the applicable fees, as stated on the Letter of Offer, is not received by the School **Last Date to Accept the Offer as stated on the Letter of Offer**; or
- b. the offer of place and scholarship is declined.

Eligibility Requirement

All scholarships are awarded on the basis that your child will maintain full time enrolment in their approved year group. Your child's scholarship may be terminated if their enrolment status changes, for example if they discontinue their school studies at GIS.

To retain your scholarship your child must also:

- Adhere to the academic and administrative policies of the school;
- Maintain their Malaysian citizenship status and advise the School within fourteen days if this changes;
- Meet any additional criteria as outlined in the letter of offer.

Scholarship Termination

The School may terminate your child's scholarship at any time if they:

- fail to meet the scholarships terms and conditions;
- Fail to maintain satisfactory academic progress;
- Are suspended or excluded from school during their course of study;
- Have provided incorrect, false or misleading information or withheld relevant information on their scholarship application or after receiving a scholarship offer.

Please note that if your child's scholarship is terminated due to any of the above reasons, you may be required to repay some or all of your scholarship.

Publicity & Promotion

If your child is offered a scholarship, their details including name, photograph, video and details of the scholarship awarded may be used by the School and/or partner organisations for promotional purposes, including but not limited to the GIS' website; social media channels; print and electronic media. If you do not wish for your child's details to be used for promotional purposes, you must notify the School in writing directly prior to accepting the scholarship. This may affect the status of the scholarship awarded.



If your child attends events held by the School, photos and videos of your child at the event (along with their name and scholarship), may be used for promotional purposes by the School and or our partner organisations, including but not limited to: the GIS' website; social media channels; print and electronic media.

It is agreed that the use of these photographs and videos shall in no way be used in any other forum other than official School business. The scholarship recipient also waives the right to inspect or approve the finished product, the advertising copy or other matter that may be used in connection therewith or the use to which is may be applied. If you do not wish for photographs and videos of your child to be used in this way, you must notify the School in writing prior to accepting the scholarship.

Acknowledgement & Agreement
